SENTENCING GUIDELINES

Offence – defilement, section 101(2), Act 29 – 1st degree felony 7 – 25 years.

Sections 29(e) and 46(1)(d) Juvenile Justice Act (Act 653) – for serious offence

1) Aggravating factors

vulnerable victim

Mitigating factors

- small age difference
- short duration
- · lesser violence
- lesser injury
- genuine relation little age difference

2) Sentence level

A – 1 aggravating factor, many mitigating factors. Sections 29(e) and 46(1)(d) Juvenile Justice Act.

3) Accused's Personal Circumstances

I don't know where my father is but my mother lives at Likpe. I have five brothers and sisters. I am the oldest. When I left the football academy and came to Accra, when I started work, I would send home some money because my mother was sick. I use to send GH¢100.00 a week when there was business or two weeks when there was no business. I love to play football. If

I can't play football, I would like to study to be a mechanic. I am pleading with the Court to forgive me. I didn't know. I promise the Court that when I leave here I will not repeat that again.

VERDICT

The accused person is convicted on his own guilty plea of the offence of defiling Esther Kpatchane, aged between 13 to 14 years by bone age determination. After considering the police medical form, investigation

caution statement and charge caution statement filed by the prosecution, the social enquiry report filed by the Probation Officer, the circumstances of the case; the fact that the accused person is 18 years old and a young offender, the fact that there is one aggravating factor – the vulnerability of the victim and several mitigating factors:

- the relationship and little age difference between the accused and the victim,
- the short duration of the act constituting the offence,
- the minimal violence used, and
- the lesser injury to the victim and the seriousness of the offence,

The accused person is sentenced to be detained at the Senior Correctional Centre at Roman Ridge for three years under sections 29(e), 46(1)(d) and (8) of the Juvenile Justice Act, 2003 (Act 653).

The accused person shall be enrolled in a training course during the period of his detention.
