**CONSENT JUDGMENT**

---

**PURSUANT** to efforts by the parties herein during pre-trial stage of the proceedings to reach an amicable settlement in respect of the ancillary reliefs claimed against each other, the parties hereby settle all issues between them in the following terms;

1. That the ordinance marriage celebrated between parties on the 26<sup>th</sup> day of April, 2008 at the Registrar General's Department in Accra be dissolved by the Honourable Court.
2. That Respondent shall pay to Petitioner lump sum financial settlement of **Thirty Thousand Ghana Cedis (GH¢30,000)** either outright or on favourable installment terms as follows:

- i. Ten Thousand Ghana Cedis (**GH¢10,000**) on or before the end of the first quarter of 2023 (31<sup>st</sup> March, 2023).
  - ii. Five Thousand Ghana Cedis (**GH¢5,000**) on or before the end of the second quarter of 2023 (30<sup>th</sup> June, 2023).
  - iii. Five Thousand Ghana Cedis (**GH¢5,000**) on or before the end of the third quarter of 2023 (30<sup>th</sup> September, 2023).
  - iv. Ten Thousand Ghana Cedis (**GH¢10,000**) on or before the end of the fourth quarter of 2023 (31<sup>st</sup> December, 2023).
3. That this Terms of Settlement is binding on each other and a party not in default is entitled to enforce the terms against the defaulting party in the event of default.
  4. That the Terms of Settlement shall be filed and incorporated into the Court's orders as Consent Judgment of the Honourable Court.

**BY COURT:** I have heard both parties to the petition and considered their evidence. I find that the marriage is broken down beyond reconciliation and accordingly dissolve. Let the Terms of Settlement filed on the 30<sup>th</sup> March, 2023 be adopted as Consent Judgment of this Court. Marriage Certificate Number RGM1054/2008 with Licence Number 2495/2008 is accordingly cancelled. Parties are to bear their own costs.
