By Defendant: - I propose to pay by monthly installments of GHC1,500 until the whole amount is finally liquidated. I promised to increase the payment as and when the situation improves and will not relent in my effort to do so.

By Plaintiff: - I am not okay with defendants proposal. I can only oblige him four (4) months within which to settle the entries debt. The proposed time is too long.

By Defendant: - I propose ten (10) months.

Judgment on admission is entered in favour of plaintiff against defendant on all three (3) claims. Pursuant to agreement reached by parties in open court. It is hereby ordered that the defendant herein shall pay the plaintiffs a total of GHC19,459 under claim one (1) of this action, in nine (9) monthly installments of GHC2,162.11 per month. 7<sup>th</sup> Installment: 05/10/2023

8<sup>th</sup> Installment: 09/11/2023

9<sup>th</sup> Installment: 07/12/2023

This matter is adjourned to Thursday, 6<sup>th</sup> April 2023 for defendant to pay the first installment of GHC2,162.00 to plaintiffs herein. Orders in respect of claims two (2)

and three (3) of this action, shall be made after the defendant has paid the principal sum of GHC19,459 to plaintiff's in full.
