OF THE PARLIAMENT OF THE REPUBLIC
OF GHANA

ENTITLED

THE ALIENS (AMENDMENT) ACT, 1965

AN ACT to amend the Aliens Act, 1963 (Act 160).

DATE OF ASSENT: *16th February, 1965*

BE IT ENACTED by the President and the National Assembly in this present Parliament assembled as follows—

1. Section 2 of the Aliens Act, 1963 (Act 160) (hereafter in this Act referred to as "the principal Act") is hereby amended by the insertion at the end of subsection (3) thereof of the following proviso:

Amendment of section 2 of the Aliens Act.

" Provided that a person who is not a citizen of Ghana shall, in addition to complying with the provisions of this subsection, report his presence in Ghana to the nearest police station not later than twenty-four hours after entry."

2. There shall be inserted immediately after section 2 of the principal Act the following new section:—

Insertion of section 2A the principal Act.

" Illegal entry.

2A. (1) A person other than a citizen of Ghana shall not enter Ghana except by one of the recognised or normal places of entry into Ghana.

(2) Without prejudice to any other penalty imposed by or under this Act, any person who contravenes the provisions of this section shall be guilty of

an offence and shall be liable on summary conviction thereof to a term of imprisonment of not less than ten years.

(3) For the purposes of this section recognised or normal places of entry are—

(a) air or sea ports in respect of which landing or docking rights have been granted to an aircraft or ship, as the case may be, in Ghana;

(b) places specified in the Schedule to this Act.

(4) The Minister may by legislative instrument amend the Schedule to this Act.”

(5) No proceeding shall be instituted for an offence under this section without the consent in writing of the Attorney-General.”

3. There shall be added at the end of section 31 of the principal Act, the following Schedule—
