### **By Court**

The parties have not lived together as husband and wife for the past two (2) years as a result of the constant fights between both parties which caused them to mutually agree for the petitioner to move out of the matrimonial home. Due to the disrespect and trauma both parties especially the petitioner claims to have gone through. He finds it intolerable to continue to live as a husband to the respondent who mocked and abused him due to his joblessness. The court is convinced the marriage between the parties has broken down beyond reconciliation. Same is hereby dissolved. The terms of settlement filed on 2<sup>nd</sup> June 2023 is hereby adopted as consent judgment of the court as follows;

a. Custody is granted to Respondent with access to the Petitioner every other weekend and half of every school vacation.

- b. Petitioner shall pay One Thousand Ghana Cedis (GH¢1,000.00) as maintenance for both children.
- c. Petitioner to pay for the educational needs of the two children fully.
