PRELIMINARY QUALIFYING EXAMINATION

Notice is hereby given that the Preliminary Qualifying Examination for all Pupil Nurses in training who have completed one or more years nursing experience in a Training Hospital approved by the Nurses' Board by the 30th December, 1970 and have attended at least seventy-five per cent of the lectures in each subject of the syllabus laid down by the Nurses' Board for the Preliminary Qualifying Examination will take place on 12th, 13th, 14th and 15th January, 1971 at 7.30 a.m.

This examination will consist of:—

- (a) Anatomy and Physiology—2 hours paper and 10 minutes oral
 - (b) Elementary General Nursing—1 hour paper and 30 minutes practical
 - (c) Hygiene and Elementary Food Values—1 hour paper and 6 minutes oral
- in accordance with Regulation 41 (a) and (b) of the Nurses Regulations of 1954.

The centres for examination will be Accra, Kumasi, Sekondi and Tamale.

FINAL QUALIFYING EXAMINATION

All Final candidates must prove—

- (a) that they will have completed three years' consecutive training in nursing of the type for which they seek registration, in a hospital approved by the Board by 30th December, 1970;
- (b) that they have attended at least seventy-five per cent of the lectures in each subject of the syllabus laid down by the Board for the Final Qualifying Examination;

(Fulbright Commission)

Applications are invited from suitably qualified Ghanaians for postgraduate scholarships at Universities in the United States during the academic year 1971–72. Scholarships are for graduates in the HUMANITIES, ARTS AND SOCIAL SCIENCES.

- (1) Candidates must be citizens of Ghana.
- (2) Must not have reached their 36th birthday by October 31, 1970.
- (3) Must be graduates with first class or second class (upper) degrees.
- (4) Preference will be given to those who have not previously studied in the United States.

SCHOLARSHIPS SECRETARIAT

INTER-AFRICAN UNIVERSITIES SCHOLARSHIP PROGRAMME: FORESTRY, DENTISTRY, VETERINARY
MEDICINE, LIBRARIANSHIP AND B.A. (FRENCH) 1971–72 AWARDS

A number of awards for degree courses in Forestry, Dentistry, Veterinary Medicine and Librarianship and B.A. (Hons.) French are being made under the Inter-African Universities Scholarship Programme of the Association of African Universities. These awards, tenable at African Universities, commence in October, 1971–72 academic year.

2. Applications are invited from suitably qualified Ghanaians who will not have reached their twenty-seventh birthday by 1st October, 1971.

Qualifications:

- (a) *Forestry*—at University of Ibadan, Nigeria. Candidates must have passed in at least five subjects, including English Language and Mathematics at G.C.E. "O" Level with two of either Physics, Mathematics, Chemistry, Botany or Zoology at "A" Level.
- (b) *Dentistry*—at University of Lagos, Nigeria and Lovanium University, Congo-Kinshasa. Candidates must have passed in at least five subjects, including English Language, Mathematics and French at G.C.E. "O" Level and two "A" Level subjects selected from Chemistry, Physics, Botany or Biology.
- (c) *Veterinary Medicine*—at the University of East Africa, Nairobi and Ahmadu Bello University, Zaria, Nigeria and Khartoum University. Candidates must have passed in at least five subjects at G.C.E. "O" Level with two "A" Level passes in Physics, Chemistry, Botany, Zoology (or Biology).
- (d) *Librarianship*—at Ahmadu Bello University, Zaria, Nigeria. Candidates must be graduates who must be first degree holders and who will take Librarianship as a career.
- (e) *Licentiate: B.A. (Hons.) Degree*—at Dakar, Abidjan and Yaounde Universities. Candidates must have passed in at least five subjects at G.C.E. "O" Level including French and English Language and two "A" Level subjects in French and one other language.

3. Students who already possess the "A" Level Certificates are eligible.

VACANCY FOR ASSISTANT REGISTRATION OFFICER

Applications are invited from suitably qualified Ghanaians for the post of Assistant Registration Officer in the Births and Deaths Registry Division of the Ministry of Local Administration.

Salary Scale.—Range 24, 29 (N/936).

Qualifications.—Applicants should not be more than 45 years of age and must: *either*

- (a) possess a good educational background preferably up to the West African School Certificate level with some experience in clerical duties; *or*
