VACANCIES FOR ENGINEER SURVEYOR AND EXAMINER OF ENGINEERS—DIVISION OF SHIPPING AND NAVIGATION

Applications are invited from suitably qualified Ghanaians for appointment as Engineer Surveyor and Examiner of Engineers in the Division of Shipping and Navigation of the Ministry of Transport and Communications.

Salary Scale.—R.84, 85—i.e. NØ5,988-NØ6,972.

Qualifications.—Candidates must possess at least a Certificate of Competency as First Class Engineer (Combined Steam and Motor) of Commonwealth validity and must have served as Second Engineer of a Foreign-Going Ship for at least 2 years. Certificate of Competency and Extra First Class and/or service as Chief Engineer of a Foreign-Going Ship is desirable.

Duties:

- (1) Inspection, survey and certification of ships under the provisions of the International Conventions on Safety of Life at Sea and on Load Lines in respect of items coming under the Engineering branch.
- (2) Implementation of the rules and regulations framed under the Merchant Shipping Act.
- (3) Conduct of examinations for issue of Certificates of Competency of all grades for officers of the Marine Engineering branch.
- (4) Conduct of inquiries into shipping casualties involving fires and explosions in Engine rooms, cargo-holds,
- (5) Any other duty of a marine engineering nature which the selected candidate may be required to perform.

Application forms may be obtained from the Secretary, Public Services Commission, P.O. Box 1618, Accra to whom they should be returned not later than 7th December, 1971. Candidates already in the Public Service should send their completed application forms through their Heads of Departments. Copies only of supporting documents should be sent. Candidates under bond to serve in any capacity are not eligible.

Applications are invited from suitably qualified Ghanaians for appointment as Nautical Surveyor and Examiner of Masters and Mates in the Division of Shipping and Navigation of the Ministry of Transport and Communications.

Salary Scale.—R.84, 85—i.e. NØ5,988-NØ6,972.

Qualifications.—Candidates must possess at least a Certificate of Competency as Master Foreign-Going of Commonwealth validity and must have served as Chief Officer of a Foreign-Going Ship for at least 2 years. Certificate of Competency as Extra Master and/or service in command or Foreign-Going ships is desirable.

- (1) Inspection, survey and certification of ships under the provisions of the International Conventions on Safety of Life at Sea and Load Lines in respect of items coming under the nautical branch.
- (2) Implementation of the rules and regulations framed under the Merchant Shipping Act.
- (3) Conduct of examinations for issue of Certificates of Competency of all grades for officers and Seamen of the navigating branch.
- (4) Conduct of enquiries into shipping casualties including groundings, stranding, etc.
- (5) Any other duties of a nautical nature which the selected candidate may be required to perform.
