GHANA NATIONAL BOOK DEVELOPMENT COUNCIL VACANCIES FOR VARIOUS POSTS

Applications are invited from suitably qualified Ghanaians for appointment to the following positions in the Ghana National Book Development Council:—

1. BOOK DEVELOPMENT OFFICER

Schedule.—The Book Development Officer will be assigned to a professional Unit depending upon his specialisation and will be expected to carry out programmes assigned to him by the head of the unit.

Qualifications:

- (a) A good first but preferably a second degree from a recognised university or F.L.A.; plus
- (b) a postgraduate diploma in Librarianship (i.e. Non-F.L.A's) or a postgraduate certificate in Education.

2. SENIOR BOOK DEVELOPMENT OFFICER

Schedule.—The Senior Book Development Officer will be responsible to the Principal Book Development Officer and will assist him in the execution of his duties including the preparation and implementation of training schemes, research programmes, technical matters, public relations and the organisation of units.

He will also act in the absence of the Principal Book Development Officer and provide consultancy service.

**INSTITUTE OF TECHNICAL SUPERVISION—WEIJA
VACANCY IN THE GRADE OF ASSISTANT PRINCIPAL**

Applications are invited from suitably qualified Ghanaians for appointment as Assistant Principal in the Institute of Technical Supervision, Weija.

Duties.—The Assistant Principal shall assist the Principal in the discharge of his duties. He shall be assigned responsibility for teaching and supervision of the work of all the Senior and Junior staff and shall be expected to discuss effectively with the Principal general problems concerning the overall administration of the Institute. He shall assist the Principal in conducting examinations and marking of scripts. He shall assume full responsibility for the Institute during the absence of the Principal.

Qualifications:

- (a) Must possess either the Final or Advanced City and Guilds Certificate or Ordinary National Certificate or G.C.E. 'O' Level with basic training in either Civil, Mechanical or Electrical Engineering practice.
