## **ENVIRONMENTAL PERMIT FOR** GREATER ACCRA REGIONAL ADMINISTRATION/AMA ACCRA WASTE PROJECT, ACCRA (EPA/EIA/0019)

In pursuance of the Environmental Protection Agency Act, 490 of 1994 (Sections 2 (i) and 12 (1)) and the Environmental Assessment Regulations, L.I. 1652 of 1999, and on the basis of the published Project Environmental Impact Statement and Addendum (January and September 1999 respectively), the Environmental Permit is issued authorizing the Greater Accra Regional Administration/Accra Metropolitan Assembly to commence the proposed Accra Waste Project at Accra.

#### CONDITIONS OF PERMIT

## Accra Waste Project is to:

- 1. (a) Comply with all the mitigation, monitoring and other environmental management provisions made in the Project EIS. The treated effluent quality as specified must be as follows:—BOD—20mg/1, SS—30 mg/1. The disposal of treated effluent must ultimately be via outfall to sea, not into the Korle Lagoon. (Possibility of connecting to the KLERP outfall could be explored). However; in the interim a contingency provision should be made to dispose of the plant effluent directly into the sea whenever the EPA effluent quality standards are not being met.
  - (b) Notify EPA on the completion of project construction (i.e. before the commencement of treatment activities).
  - (c) Notify EPA of any major changes in the planned project development/operation contrary to what is provided in the project EIS.
  - (d) Submit an Annual Environmental Report on the project operations in accordance with Regulations 25 of L. 1.1652 of L.I. 1652.
  - (e) Submit an Environmental Management Plan in accordance with Regulation 24 of L.I. 1652.
- Notwithstanding this Permit, the project is further subject to other relevant regulations and permits per-2. taining to the sector and must be observed.
- An Environmental Certificate must be obtained after a year's satisfactory performance and compliance with relevant permit conditions in accordance. 3. with relevant permit conditions, in accordance with Regulation 22 of L.I. 1652.
