EXPRESSION OF INTEREST

This request for expressions of interest follows the general procurement notice for this project that appeared in Development Business No. 443 of 31 July 1996.

The Government of Ghana has applied for a credit from the International Development Association (IDA), and intends to apply part of the proceeds of this credit to payments under the contract for the Supervision Consultancy for the Prestea-Obuasi Transmission Project, Contract TK-11.

The services include the supervision of the implementation of the Prestea-Obuasi 161kV overhead line, including the expansion of both Prestea and Obuasi Substations, the erection of a fibre optic cable and accessories and the upgrading of communication systems at both substations and at the systems control center. The services include overall management, engineering, procurement/inspection, construction co-ordination/quality assurance and testing/commissioning.

The Volta River Authority, acting on behalf of the Government of Ghana, now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriately skilled staff, etc.) Consultants may associate to enhance their qualifications.
