GAZETTE NOTICE—PRESIDENTIAL AND PARLIAMENTARY ELECTIONS, 2000

The Public is hereby informed that for purposes of voting in the forthcoming Presidential and Parliamentary elections 2000 and future public elections, only Photo Voter Identity cards shall be used. Thumbprint Identity Cards shall no longer be valid for voting.

Any voter who presents himself/herself with a Photo Identity Card, shall go through the following steps for identification:

- (i) The Presiding Officer shall check for the name in the Name Reference List;
- (ii) If the name is not on the list, the person will be politely told to go away from the Polling Station;
- (iii) If the name is on the list and all the candidate agents affirm that they know the person, he/she shall be allowed to go through the voting steps straightaway;
- (iv) If there is any doubt as to the identify of the voter, the Presiding Officer shall pick the original registration form of the person, using the voter identify number on the Name Reference List; (v) The Voter shall be required to confirm certain details provided on the registration form, to enable
- him/her to be allowed to vote; (vi) The verification of identity of such a voter shall take place in the presence of the party agents.
