# **Director's Loan Agreement**

Box CT 3119 Cantonments, Acera, Ghana (hereinafter "RORAIMA") and COLIN MARS VICKERIE, personal and as Director of Roraima Financial Services (Nevis) having his address at 37 People's Line Road, Somerset, NJ 08873 (hereinafter "Director") hereinafter may be referred to as the "Parties" and each, singly, "Party"), agree to the following (the "Agreement"):

WHEREAS RORAIMA is the recipient of an unrestricted license for the Electronic Data Management Services (EDMS) platform offered by Roraima Financial Services (Nevis), the said platform having over 17 various modules.

AND WHEREAS, Mr. COLIN MARS VICKERIE, a DIRECTOR and FOUNDER of RORAIMA FINANCIAL SERVICES, who have caused the rights of the EDMS platform to be transferred to RORAIMA FINANCIAL SERVICES, stands personally as guarantor of the cost of the platform under this Director's Loan Agreement between RORAIMA DATA SERVICES (GHANA) and Mr. VICKERIE.

AND WHEREAS, Roraima desires to use such modules to provide services to governmental and business entities in Ghana for certain remuneration;

NOW, THEREFORE, in consideration of mutual covenants and agreements contained herein, and mutual benefits to be derived here from, the Parties intending to be legally bound, hereby covenant and agree as follows:

- 1. <u>Recitals</u>: The foregoing recitals are true and correct and incorporated as if fully set forth herein.
- 2. Dutics & Milestones: Roraima agrees to provide services to entities in Ghana and to represent the Roraima brands in various marketing exercises and as directed by its management.

management. Affiliate will take direction from Roraima management and perform duties as requested.

- 3. Terms and Termination:
  - a. The term of this Agreement shall be unlimited.
  - b. RORAIMA may immediately terminate this Agreement in the event Affiliate materially breaches any duty or responsibility under this Agreement, commits any material act of dishonesty, discloses confidential information or trade secrets, is guilty of gross carelessness or misconduct, neglects Affiliate's duties under this Agreement (including but not limited to performing the requested services including as set forth in paragraph 2), or acts in any way that has a direct, substantial and adverse effect on RORAIMA's reputation.
- 4. <u>Cost of technology and cost of operations:</u> Roraima will determine the schedule of payments to be made by its Affiliate for the use of the EDMS and payments will be scheduled to commence effective from January 2015. Roraima will fund the operations of its Affiliate as needed and repayment of funding will be determined and shall commence January 2015.

#### 5. Non-Disclosure/Confidentiality:

- 2. <u>Non-Disclosure of Confidential Information:</u> Affiliate agrees, except as may be required by law or as may be permitted by written instructions of RORAIMA, both during the term of this Agreement and thereafter, not to directly or indirectly use or disclose any of the Confidential Information at any time except as may be necessary in the ordinary course of providing the services hereunder. "Confidential Information" shall mean trade secrets, confidential knowledge, data or any other proprietary information of RORAIMA, its subsidiaries or affiliates. By way of illustration but not limitation, "Confidential Information" includes customer lists, financial information, marketing information (including, without limitation, marketing strategies, customer names and requirements and products and services, prices, margins and costs), product and pricing information, technical information, pending projects and projects and proposals, research and development strategies and other confidential business information, including, but not limited to, third party information described in paragraph 5(c) hereof.
- b. <u>Return of RORAIMA Property/Confidential Information</u>: In the event of the termination of this Agreement, for any reason, or at any time at the request of RORAIMA, Affiliate agrees to immediately deliver to RORAIMA all materials, documents, and data of any nature containing or pertaining to any Confidential Information and will not keep any such materials, documents, data, or any

reproduction thereof. Affiliate further agrees that he/she will certify in writing that he/she has satisfied their obligations under this paragraph within 10 days of a written request by RORAIMA.

- c. <u>Third-Party Information:</u> Affiliate recognizes that RORAIMA has received and in the future will receive information from third parties which is third party private or proprietary information subject to a duty on RORAIMA's part to maintain the confidentiality of such information and to use it only for certain limited purposes. Affiliate agrees that during the term of this Agreement and thereafter. Affiliate owes RORAIMA and such third parties a duty to hold all such private or proprietary information-received from third parties in the strictest confidence and not to disclose it. except in accordance with such duty and as necessary in carrying out Affiliate's services for RORAIMA hereunder, consistent with RORAIMA's Agreement with such third parties, and not to use such information for the benefit of anyone other than for RORAIMA or such third parties.
- d. Equitable Relief: Affiliate acknowledges that any breach or threatened breach by Affiliate of the non-disclosure provisions of this Agreement will result in immediate and irreparable harm to RORAIMA, for which there may be no adequate remedy at law, and that RORAIMA will be entitled to equitable relief to restrain Affiliate from violating the terms of the non-disclosure provisions hereunter, or to compel Affiliate to cease and desist all unauthorized use and disclosure of the Confidential Information. RORAIMA shall be entitled to recover from Affiliate any costs and expenses incurred in obtaining relief against breach of the non-disclosure provisions of this Agreement by Affiliate including, but not limited to, legal, enforcement and collection fees and costs. Nothing in this Agreement shall be construed as prohibiting RORAIMA from pursuing any other remedies available to it for such breach or threatened breach, including recovery of damages from Affiliate.

6. <u>Severability</u>: If any provision of this Agreement is determined to be invalid, illegal or unenforceable, then, to the extent such invalidity, illegality or unenforceability shall not deprive either Party or any material benefit intended to be provided by this Agreement, all of the remaining provisions of this Agreement shall remain in full force and effect and shall be binding upon the Parties.

7. <u>Waiver</u>. Failure to insist upon strict compliance with any of the terms, covenants or conditions hereof shall not be deemed a waiver of such terms, covenants or conditions, nor shall

Waiver of Trial by Jury: The Parties irrevocably waive all rights to a trial by jury in any judicial proceeding involving this Agreement. This provision is a material inducement for each Party to enter into this Agreement and to perform bereunder.

c. <u>Attorney's Fees. Court Costs. ctc.</u>: <u>Prejudgment Interest</u>; <u>Post-judgment Interest</u>: In the cvent either Party must bring suit or other cause of action, then the prevailing Party shall be entitled to all reasonable altorney's fees, court costs, and any reasonable out-of-pocket expenses expended. Lastly, any judgment awarded a prevailing Party shall accrue pre- and post-judgment interest at the highest rate allowed Ghana.
