
SUBJECT: AIR OPERATOR CERTIFICATION

DISCONTINUANCE OF THE ISSUANCE OF "OPERATING PERMITS" PENDING CERTIFICATION

PURSUANT to the powers conferred on the Director- General by Section 9 of the Ghana Civil Aviation Act, 2004, Act 678 (as amended by Section 3 of the Ghana Civil Aviation (Amendment) Act, 2015, Act 906), THIS Directive is hereby made to take immediate effect from the date of this publication.

In accordance with the requirements of the Ghana Civil Aviation Authority, IT IS HEREBY DIRFCIED that the provisions with respect to the Issue of an Operating Permit pending certification provided in Part 9, sub-regulation 9.1.1.6 (b) of the Ghana Civil Aviation (Safety) Regulations, 2011, L.I. 2000, SHALL from the date specified in this publication cease to be applicable.
