**GAZETTE NOTICE:****NOTICE GIVEN BY THE MINISTER FOR AVIATION WITH RESPECT TO THE COMMITMENT OF THE REPUBLIC OF GHANA TO THE IMMEDIATE IMPLEMENTATION OF THE YAMOUSSOUKRO DECISION UNDER THE TERMS OF THE DECLARATION OF SOLEMN COMMITMENT IN LINE WITH THE AFRICAN UNION (AU) AGENDA 2063**

**WHEREAS** the Republic of Ghana is a member State of the African Union and a signatory to the Treaty establishing the African Economic Community signed on June 3, 1991 (the "Abuja Treaty");

**WHEREAS** Article 10 of the Abuja Treaty provides that the Assembly of Heads of State and Government shall act by Decisions and that such Decisions are binding on member States and organs of the Community as well as Regional Economic Communities;

**WHEREAS** the Assembly of Heads of State and Government of the African Union through Decision AHG/OAU/AEC/Dec.1 (IV) in Lomé, Togo, in July 2000, endorsed the Yamoussoukro Decision within the context of the Abuja Treaty;

**WHEREAS** in compliance with the Declaration of the Assembly of Heads of State and Government of the African Union (Assembly/AU/Decl.1 (XXIV) and in particular its Declaration to Support the initiative of Championing

States to open their respective air transport markets immediately and without conditions, State Parties including the Republic of Ghana are required to publish or gazette in accordance with their national law that they are committed to the immediate implementation of the Yamoussoukro Decision under the terms of the Declaration of Solemn Commitment in line with the AU Agenda 2063;

**WHEREAS** in addition to the foregoing, the Republic of Ghana has notified the other State Parties, especially the signatories to the Declaration of Solemn Commitment that its skies are liberalized in accordance with the Yamoussoukro Decision;

**NOW THEREFORE, I, Cecilia Abena Dapaah,** Minister for Aviation of the Republic of Ghana, do give notice of the Republic of Ghana's commitment to the immediate implementation of the Yamoussoukro Decision under the terms of the Declaration of Solemn Commitment in line with the AU Agenda 2063 and that the Republic of Ghana has notified the other State Parties, especially the signatories to the Declaration of Solemn Commitment that its skies are liberalized in accordance with the Yamoussoukro Decision.
