389 of 1971 of Ghana.

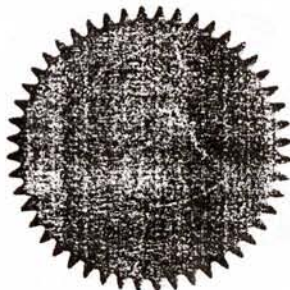
