GAZETTE NOTIFICATION

ESTABLISHMENT OF APPEALS TRIBUNAL FOR THE NATIONAL BIOSAFETY AUTHORITY (NBA)

The Minister for Environment, Science, Technology and Innovation (MESTI), acting in accordance with Section 26 of the Biosafety Act, 2011 (Act 831) has established a five (5) member Appeals Tribunal to adjudicate on matters regarding decisions taken by the Board of the NBA on applications on the development, use, handling and transfer of Genetically Modified Organisms (GMOs) in Ghana. Therefore, any person aggrieved by:

- (a) a refusal to grant an approval under the Act, or
- (b) the conditions of approval under the Act, or
- (c) the revocation, suspension or revision of an approval under the Act, or
- (d) a refusal to treat an application as confidential

may appeal, within thirty days of the decision of the Board, to the Appeals Tribunal in the prescribed manner
